DR. HYGINUS 'GENE' LEON

Division Chief

International Monetary Fund (IMF)

Dr. Gene Leon, the Division Chief at the International Monetary Fund (IMF) and Mission Chief for Zimbabwe, is an experienced economist delivering macro-financial advice, academic scholarship and thought leadership in the areas of Econometrics, Modeling and Forecasting, Macro-vulnerability Analysis and Risk Management for more than 30 years. In leadership and technical capacities at multiple institutions including the IMF, Central Bank of Barbados, and the Caribbean Development Bank, and the State University of New York, Dr. Leon has applied extensive knowledge of macro-financial, macro-fiscal, and intersectoral linkages to promote the integration of socio-political analysis in economic policy and strategy. He has led or contributed to key analytical and policy initiatives, undertaken program, bilateral and multilateral surveillance work, and delivered technical assistance and training to country officials. He has an advanced understanding of the complexities of financial and foreign exchange markets in both developed and emerging markets, including the impact of risk and vulnerabilities on financial sector stability. As a senior policy and technical advisor to country authorities, his experience encompasses financial market transitions, crisis management, and financial sector development in diverse economies such as Iraq, Oman, Qatar, United Arab Emirates, Jamaica, The Bahamas, Nigeria, and Zimbabwe. A strategic thinker and effective communicator, Dr. Leon adopts an

inclusive and collaborative approach to engage, influence, and inspire stakeholders to embrace change in a holistic and coherent manner. He holds a PhD (Economics/Econometrics), University of Southampton, U.K. (1986). Thesis: Testing the Monetary Approach to the Balance of Payments: A Case Study Based on Jamaica, and a B.Sc. (Economics), 1st Class Honors. University of London, U.K. (1979).

*Dr. Justine Ram* is Director of Economics at the Caribbean Development Bank - in charge of economic analysis, country strategy and programming, research and Economic Operations in the Bank's 19 Caribbean borrowing member countries. As a Director, he is also a member of the senior management team of the Bank. He has over twenty years or professional experience.

He has previously worked as Supervisory Economist with the Mayor of London and Greater London Authority, as an economist with the United Kingdom's Government Department for Transport, Senior Global Economist with Worley Parsons, as Technical Director with Jacobs Engineering, and as analyst with Thomson/Reuters. Justin also taught at the London School of Economics and Political Science and was Lecturer in Economics at the University of the West Indies (UWI). He has also worked as a consultant on many

Dr. Terrence W. Farrell has worked extensively in both the public and private sectors. After lecturing in Monetary and Development Economics at UWI, St. Augustine, he joined the Central Bank of Trinidad and Tobago in 1980 and was Director of Research (1984-1989) and

later Deputy Governor (1992-1995).

He was involved in key policy initiatives including the debt restructuring and IMF programmes in 1987-1991 period, exchange control liberalization and the flotation of the Trinidad and Tobago dollar in 1993. Within the private sector, he was Regional Manager for a regional IT Services company from 1995 to 1997, Group Executive Director at Guardian Holdings Limited from 1998-2005, responsible for Strategy and

Business Development and President of Guardian General Limited from 2005-2006.

He was President of Business Insight Limited a strategy and business development consulting firm from 2006-2008 and Group Chief Executive Officer of One Caribbean Media Limited from 2008 to 2010. He is a director of Republic Financial Holdings Limited, Eastern Caribbean Financial Holdings Limited, TATIL and TATIL Life and CREDI, the Catholic tertiary education institute.

Dr. Farrell studied Economics at the University of the West Indies, St. Augustine and at the University of Toronto where he obtained his Ph.D. in 1979, and also holds an LL.B (London) degree and the LEC from the Hugh Wooding Law School. He was admitted to practice law in Barbados and in Trinidad and Tobago in 2013 and is a Certified Mediator. He is a Fellow of the Institute of Banking and Finance of Trinidad and Tobago, a Member of the Chartered Institute of Arbitrators and a member of the Caribbean Corporate Governance Institute.
