I am indeed extremely delighted to welcome you to our Annual Youth Empowerment Forum, which forms an essential part of the Division of Finance and the Economy's Finance Month celebrations. The Division, over the years, has given strategic importance to and placed our young people at the forefront of our development thrust, with the Youth Empowerment Forum serving as one of our flagship events during our celebrations. For me, it's always a pleasure to be in company of fellow young people, to sit and discuss issues which are pertinent to your development. This morning's Forum comes at a time when as a world we are navigating the challenges arising out of the COVID-19 pandemic. As such, our theme for this year's Finance Month celebrations is "Recalibrating Our Priorities Toward a More Resilient Future". We recognize that the future cannot be discussed without the direct engagement and input of those whose future we are entrusted with as a duty of care.

Over the last three years, this Administration was proud to have:

Offered a number of youth professional training programmes for young adults, such as the World of Work Programme and the Youth

Energized for Success Summer Internship Programme, to enhance employability of approximately 500 young persons on the island;

Introduced a Science Technology Engineering and Mathematics (STEM) after-school programme to provide students in Tobago with greater opportunities to access new and emerging technologies such as Electronics, Artificial Intelligence, Virtual Reality, Advanced Coding, Advanced Robotic and Multipurpose Drones. Over 230 students benefited from the STEM training;

Hosted the You-Biz Summer Camp and Financial Literacy Tours;

Conducted Financial Literacy Youth Expositions to provide exposure and improve financial literacy and entrepreneurial skills; and,

Constructed the Tobago Innovation Centre to provide training and certification in IT and ICT related disciplines.

In addition, we have assisted a significant number of young persons with an interest in entrepreneurship by providing several millions in loans and grants under the Enterprise Assistance Fund (EAF) and Enterprise Assistance Grant Programmes (EAGP). The SME sector in Tobago has been well supported over the years through collaborations of the Business Development Unit (BDU), the Strategic Business Support and Development Unit (SBSDU), the Venture Capital Equity Fund Limited (VCEFL) and the Eco-Industrial Company of Tobago (EIDCOT) Limited. As a result, we have increased the availability of a number of products and services of Tobago origin, both on a national and an international level.

As young adults you will agree that we live in an environment of constant change and disruption. The onslaught of the COVID-19 pandemic has significantly altered social norms, and placed greater demands on policy makers and the society as a whole, to devise creative and sustainable solutions. These solutions will not only ensure that our health and safety is not compromised, but also that the island's economic activity continues unabated. Therefore, in keeping with our theme and central to this approach, is a renewed commitment to leverage ICT as an engine for not only digital transformation, but as an enabler of socio-economic transformation.

One of our key strategies for this digital evolution has been the Intelligent Island Initiative which I have outline in my recent Budget Statement. Additionally, we have taken steps to expand the service offerings at the Tobago Information Technology Limited (TITL) and to build out our knowledge networks by hosting our own innovation conferences and camps, and develop further partnerships within the local and regional technology community. Another key pillar of this strategy is the establishment of a Tier III Data Centre at the COVE Eco-Industrial Business Park; and we certainly look forward to the business opportunities to be created out of the Data Centre.

As we continue our dialogue pivoting towards a 'The New Agenda', this year's Forum will focus on accelerating the island's digital agenda and

facilitating the necessary investment in an innovation ecosystem. We will also focus specifically on the issue of food security by looking at the agricultural sector and entrepreneurial initiatives and opportunities within this sector in order to improve food security. I know that you can look forward to exciting presentations and equally engaging discussions with today's caliber of progressive and forward thinking panelists.

Arising out of Tuesday's discussions at the Tobago Economic and Business Outlook Conference, we are in the process of establishing a Business Advisory Council to continue the engagement and to drive the recommendations made by those panelists. I have no doubt that today will be as fruitful and engaging. Under the current circumstances, we are unable to come together in our large numbers as we normally do, however we are joined by many other young persons via social media, and the World Wide Web and I am certainly looking forward to their contributions.

On behalf of the Division of Finance and the Economy, I take great pleasure in welcoming you to this year's Youth and Empowerment Forum.
